RE: VOLUSIA SHERIFF'S OFFICE TRAVEL FORM

Dear Sheriff Chitwood,

I am President of the Florida Action Committee, Inc., a 2,500+ member non-profit that advocates for public safety based on empirical evidence and best practices. Our focus is on the population of persons required to register as sex offenders in Florida. Among our members are persons required to register.

It was recently brought to our attention that persons required to register who report domestic travel in your county are required to provide additional information not required by statute. Specifically, they are required to fill out, sign and even thumb-print a form including the questions; "Purpose of Travel (Be Accurate)", "Mode of Transportation", and "Please email your flight information to CCU@VCSO.US"

Pursuant to F.S. §§ 943.0435(7) and 775.21(6)(i) the mode of travel is only required for international travel, not domestic. The Purpose of travel is not required under *either* domestic or international travel.

I am writing to ascertain (a) under what authority you are requesting an individual's purpose of travel, (b) under what authority you are requesting an individual's mode of transportation for domestic travel, (c) which individuals or entities are provided access to this information, and (d) for what purpose this information is collected.
